The review criteria online is as follows:

In this section you are required to complete the questions and scoring related to the review of the abstract.

For scales from 1 - 5, 1=low and 5=high.

Innovation

(New angle; creative method/s or program; shows initiative)

Evidence

(How are they backing up what they are saying?)

Interest to mental health services

(Research, education, policy, clinical practice etc. related to services)

Clarity of expression

(Can you understand the abstract?)

"Feel" factor

(I.e. I feel that this paper is worthwhile)

The follow section require yes/no/maybe answers:

Complies with abstract guidelines	yes / no
Includes 2 learning objectives	yes / no
Includes 2 references	yes / no

Include in program: yes / no / maybe

The final section enables you to comment and add additional keywords:

Suggest further keywords (up to 3) to describe this abstract - to assist us with designing the program.

Comments - general comments about whether / why / why not include in program
